A comprehensive review of Council's Sewage Treatment Plant Strategy was recently completed. This report presents an updated strategy and seeks Council's endorsement of the preferred strategy for long term solutions for South Rockhampton and Gracemere STP.

Gracemere and South Rockhampton Sewerage Strategy Review

SRSTP +GSTP Long term strategy

External review has confirmed and validated strategy adopted in 2014 that was to closedown GSTP and built a new larger SRSTP.

SRSTP +GSTP Long term strategy

- Following 4 Options were analysed,
 - Construct new SRSTP 35,000EP + Upgrade 1x 12,500EP existing process train + refurbish and keep GSTP.
 - 2. Construct new SRSTP 25,000EP + Upgrade both 12,500EP each existing process trains + refurbish and keep GSTP.
 - 3. Construct new SRSTP 35,000EP + Upgrade both 12,500EP each existing process trains but **close** GSTP.
 - 4. Construct new SRSTP 50,000EP and close GSTP.

Comparing the Long-Term Strategies

The costs for the four strategies are compared below. All figure 1 in 2021 no provision for escalation.

Strategy	Capital Cost	NPV	Refurb Cost Risks
New 35,000EP SRSTP	\$110.7M	\$97.5M	Refurb one (1) SRSTP existing process train, + Potential refurb at GSTP
New 25,000EP SRSTP	\$114.0M	\$99.8M	Refurb two (2) SRSTP existing process trains, + Potential refurb at GSTP
As per 2 above + Close GSTP	\$130.3M	\$106.2M	Refurb two (2) SRSTP trains
New 50,000EP SRSTP	\$117.5M	\$103.8M	Nil

Recommended Long Term Strategy

- Construct new SRSTP 50,000EP and close GSTP. Main Reasons
 - 1. All other options involve multiple plants at two sites, requires significant operational cost / resources,
 - 2. The new 50,000EP single plant avoids all of the refurbishment cost risks, and has benefits of economies of scale, and fewer operational resources,
 - 3. The new 50,000EP strategy is considered to be the best strategy for Council and is recommended, subject to funding availability.

Short Term Issues & Strategy

 Several Short Term Issues identified both at GSTP & SRSTP that require fixing in the meantime to stabilize SRSTP until new SRSTP 50,000EP is commissioned,

GSTP

- 1. Non-Compliance with the 'zero discharge' EA,
- 2. Odour,
- 3. Biosolids/sludge, and
- 4. Maintenance.

Existing SRSTP

- 1. H_2S gas,
- 2. Hydraulic capacity, and
- 3. A number of Issues (Aeration diffusers, penstocks, sludge digesters, sludge lagoons).

Other Networks Priority Projects identified to implement Short & Long Term Strategy

- Pipeline between GSTP and SRSTP to transfer raw sewage from GSTP to SRSTP,
- Arthur Street main Sewage Pump Station is at the end of its useful life and must be replaced as a priority project,
- Cost of these two network projects is estimated at \$10M,
- These must be completed by March 2023.

Current Position

- Pipeline from GSTP to SRSTP started but not completed,
- Replace Arthur Street SPS investigation works commenced.

Recommendation:

- Council accept recommendation for Long Term Strategy for GSTP & SRSTP,
- Council accept the short-term actions for Gracemere and South Rockhampton STP'S,
- Council reallocate the Gracemere STP upgrade budget to the North Rockhampton STP Project
