# FACT SHEET

## Sustainability in Action Photo Competition Conditions of Entry

The Promoter is Rockhampton Regional Council.

### Requirements

- All photographs must be captured within the Rockhampton Region.
- All photographs must be given a title, description of the sustainability action demonstrated in the photo and a quote from member/s of the household or student/s (100 words or less) about the importance of this sustainability action.
- Photographs must be full colour.
- Photographs must be landscape format.
- Photographs must be a single image – collages will not be accepted.
- Photographs must be recent (taken within the last two years) and entries with date stamps will not be accepted.
- Photographs must not rely heavily on use of image manipulation programs, filters or overlays.

### Permissions

- By entering the competition, the entrant represents, acknowledges and warrants that the submitted photograph entry is an original work and no other party has any right, title, claim or interest in the photograph.
- The entrant retains the rights to the submitted photograph, however by entering the competition you grant Rockhampton Regional Council the right to copy and publish your submitted photograph entry in print or digital form, for ongoing advertising and promotion of the Rockhampton Region.
- Rockhampton Regional Council may publish your submission on our websites, social media pages, in print or digital publications.
- Entering the competition is evidence of the entrant's consent to these Conditions of Entry.
- For Households – The entrant must be a resident of Rockhampton Regional Council Local Government Area.
- For Schools – The entrant must be an employee of a primary or secondary school within the Rockhampton Region with appropriate administration approval to submit a photograph on behalf of the School. The School must hold a completed and signed Media Release form for all recognisable persons within a photograph.

### Submitting

- A maximum of 12 photographs may be submitted by any one entrant (schools are permitted multiple entries from different classes).
- Photographs must be provided in JPEG (.jpeg) digital format.
- Photographs and a completed Sustainability in Action Competition Entry Form must be submitted digitally via email to [sustainability@rrc.qld.gov.au](mailto:sustainability@rrc.qld.gov.au) or by completing the online Sustainability in Action Photo Competition Entry Form.
- Competition opens Wednesday 5 June 2024 and closes at 5pm Friday 16 August 2024.

### Judging

- Entries will be judged by a panel that will evaluate the entries based on the following criteria:
  - Extent to which the photograph captures the essence of the 'Sustainability in Action' themes (weighting 50%); and
  - Artistic/visual appeal (weighting 50%).
- Judging will take place in August 2024, and winners will be notified by telephone or email of the outcome on or before 13 September 2024. The winners will be subsequently announced on Rockhampton Regional Council's Facebook page and website. The judges' decision on all matters relating to the competition is final and no correspondence will be entered into.
- Rockhampton Regional Council reserves the right to remove from the competition any photographs deemed unsuitable for public viewing.
- Council intends to award 12 School Sustainability Champions and 12 Household Sustainability Champions (subject to suitable entries being received). Each winner will feature in Council's Living Sustainably program resources and receive a certificate, a sustainability pack, and \$200 which will be paid by an electronic funds transfer.
